Affidavit of Peter Hegarty

- [7] I have read the affidavit of Peter Hegarty sworn on 17 December 2021 and filed in these proceedings (**Hegarty Affidavit**).
- [8] At paragraphs 13-19 of the Hegarty Affidavit, Peter Hegarty deposes to certain matters on the basis of being informed of those matters by myself. Save for the following clarification, I say those matters are true.
- [9] At paragraph 15 of the Hegarty Affidavit Mr Hegarty states that the Company was the responsible entity of three unregistered managed investment schemes. As set out in further detail below some of those managed investment schemes were registered.

Further Background

- [10] The Company is and at all material times was:
 - (a) the responsible entity of the Equititrust Income Fund (EIF) (ARSN 089 079 854), a managed investment scheme registered under Chapter 5C of the *Corporations Act 2001* (Cth) (Act), a true copy of a search of a current search of the records held by ASIC in respect of the EIF appears at page 39 of the Exhibit;
 - (b) the trustee of the Equititrust Premium Fund, an unregistered managed investment scheme formed on 14 May 2003 (EPF); and

- (c) the responsible entity of Equititrust Priority Class Income Fund (ARSN 089 079 729) (EPCIF), a managed investment scheme registered under Chapter 5C of the Act a true copy of a search of a current search of the records held by ASIC in respect of the EPCIF appears at page 51 of the Exhibit (together, the Funds).
- [11] At all material times the Company has held an Australian Financial Services
 Licence number 230471 (AFS licence), The AFS Licence is currently suspended. A
 copy of the results of a search of the registers maintained by ASIC in respect of
 AFSL licence holders is at page 60 of the Exhibit.
- [12] The assets of the Funds were primarily comprised of loans to third parties secured over real property assets. A large number of these assets were in a distressed state prior to my appointment and the appointments referred to below.

Current Status of the Funds

EIF and EPCIF

- [13] On 21 and 23 November 2011, Applegarth J made Orders (documents 37 and 39 on the Court file) in this proceeding that, *inter alia*:
 - (a) the Company wind up the EIF and EPCIF;
 - (b) Mr David Whyte (Mr Whyte) of BDO be appointed as the person responsible for ensuring the winding-up of both of EIF and EPCIF in accordance with their Constitutions, pursuant to section 601NF of the Act;
 - (c) Mr Whyte be appointed as Receiver of the property of EIF;
 - (d) Mr Whyte be appointed as Receiver of the property of EPCIF; and
 - (e) the rights of the secured creditors of the Company and EIF (including the right to appoint their own receivers) not be affected by the Orders.
- [14] Mr Whyte remains in the above positions in respect of the EIF and the EPCIF.

The EPCIF

- [15] I am informed by the affidavit of David Whyte filed 13 May 2020 and believe to be true that:
 - (a) there are only five unitholders of EPCIF;

- (b) the only assets held by the EPCIF are units which the EPCIF holds in the EPF; and
- (c) as at May 2020 Mr Whyte anticipates that the current value of the assets of the EPCIF is nil.
- [16] I have no reason to believe that the matters in the previous paragraph are different as at the date of swearing this my affidavit.

EPF

- [17] To date Mr Albarran and I have made no recoveries in respect of the assets of the EPF and there are currently no material assets to distribute to the beneficiaries of the EPF.
- [18] Mr Albarran and I are currently prosecuting proceedings in the Supreme Court of Queensland on behalf of the Company seeking damages from:
 - (a) Mr David Tucker and a related entity for, among other things, breach of his duties as a director of the Company and the related entities involvement in the same;
 - (b) Mr Richard Cowen and David Tucker carrying on practice as partners under the name Tucker and Cowen Solicitors for breach of contract, breach of trust and relief in the nature of vicarious liability in respect of the breaches of Mr Tucker;
 - (c) TCS Solicitors Pty Ltd for breach of trust; and
 - (d) Mr Cowen for being involved and/or knowingly concerned in Mr Tucker's breaches of duty,

(Director Proceedings).

- [19] The Director Proceedings commenced on 10 July 2018.
- [20] The Director Proceedings have been and are being conducted with funding provided by a commercial litigation funder. The terms of the litigation funding agreement are confidential.
- [21] The Director Proceedings are currently listed for hearing in the Supreme Court of Queensland from 14 February 2022 to 4 March 2022.

Points of Claim and Categories of Particulars

- [22] The facts matters and circumstances the subject of the points of claim (PoC) filed in these proceedings are true and correct and to the extent they are opinions represent my honestly held opinions based on my experience as a liquidator.
- [23] The categories of particulars, filed in these proceedings, are categories of work that has been performed which I believe is work that relates to the EIF. This is my honestly held opinion which is based on my experience as a liquidator and knowledge of the work that has been performed.

Remuneration and costs

- [24] The amounts of the Liquidation Remuneration, Liquidation Expenses and Administration Expenses stated in the PoC were accurate as at the date of the document. Obviously, further work has been undertaken since then.
- [25] With the exception of the Director Proceedings which concern the EPF the Company is unfunded and the remuneration and expenses have been carried by my firm.
- [26] With the exception of claiming my remuneration from trust assets and the matters discussed in this affidavit there are likely no further substantive tasks to be completed in the Company's liquidation.
- [27] I believe that the particulars that have been sought by Mr Whyte in Gadens letter of 27 October 2021:
 - (a) will take approximately 6 weeks to complete as it involves the review of over seven years' worth of time entries; and
 - (b) cost approximately \$50,000 in time incurred by staff of Hall Chadwick.
- [28] I believe that the remuneration which would be incurred in preparing the proceedings for a final hearing on the question of the quantification of the remuneration claimable from the EIF, including the costs of employee of Hall Chadwick liaising with our lawyers as to the preparation of detailed evidence for those proceedings, will be approximately \$50,000 to \$100,000.
- [29] As to the Order Remuneration, particulars of the sum of \$85,382.50 plus GST are set out in the schedule at page 64 of the Exhibit.
